

HIGHEST PRESIDENTIAL PRIMARY TURNOUT IN 20 YEARS

Turnout reached 43 percent in suburban Cook County for the Feb. 5, 2008 Presidential Primary, surpassing turnout levels for the last five Presidential Primary elections. A 40 percent turnout in 1992, when Bill Clinton was on the ballot, was the previous high in the last two decades until 585,449 voters showed up at the polls for the 2008 primary.

PARTISAN TURNOUT BY TOWNSHIP SUBURBAN COOK COUNTY FEBRUARY 2008



PARTY SHIFT TO DEMOCRATIC BALLOTS CONTINUES IN SUBURBAN COOK



A growing majority of suburban Cook County voters this February cast Democratic ballots. About 76% of the 585,449 voters cast Democratic ballots and 23% voted Republican, greater than a 3-to-1 margin. This exceeded the record 69% Democratic ballots pulled in the March 2004 Presidential Primary.

Another 570 voters – less than one percent – voted in the Green Party primary this February, the first time a Green Party ballot was offered statewide.

PARTY SHIFT ON TOWNSHIP LEVEL CREATES NEAR DEMOCRATIC SWEEP

Voters in all but one of 30 suburban townships – Barrington – cast more Democratic than Republican ballots. This breaks the record set in the last presidential primary, in 2004, when 27 townships cast a majority of Democratic ballots.

PRESIDENTIAL PRIMARY RESULTS: McCain Sweeps Suburban Townships

Sen. John McCain “dropped out” nearly three weeks before Illinois’ 2000 primary, but he still won about one-fourth of Republican votes in suburban Cook County. Frontrunner George Bush won every township in that election.

On Feb. 5, it was McCain who swept the townships, winning 52 percent of votes, or 70,644 votes, to Mitt Romney’s 29 percent. McCain’s top three townships in 2000 – New Trier, Northfield and Evanston – continued their strong support in 2008.

PRESIDENTIAL PRIMARY RESULTS: OBAMA TAKES 21 OF 30 TOWNSHIPS

Senator Barack Obama won 21 of 30 townships in the Cook County suburbs, two fewer than he won during the March 2004 Senate primary.

On February 5, 2008, nine of 30 townships went for Clinton, while Obama lost only seven townships in 2004. Maine, Norwood Park and Berwyn—previously in the Obama column—went to Clinton. But this time around Obama picked up Worth, which had gone to Dan Hynes, one of the seven Democrats vying for their party’s Senate slot in 2004.

Obama did earn many more votes (281,156) in the Presidential Primary than the last Democrat to win a Presidential Primary in Illinois—John Kerry, who won 193,064 suburban votes in 2004.

RESULTS OF CROWDED DEMOCRATIC STATE'S ATTORNEY'S RACE

Richard Devine's retirement prompted a crowded race for State's Attorney. Anita Alvarez won with 26.8% of the vote, slipping past Tom Allen (26.1%) and Larry Suffredin (25.2%).

Allen actually won more townships (12) than Alvarez (nine). Suffredin won six and Brookins, three. In the November general election, Alvarez will face County Commissioner Tony Peraica, who ran unopposed on the Republican ballot.

TOUCH SCREEN vs. PAPER BALLOT VOTING ON ELECTION DAY

About 61 percent of voters on Election Day cast their ballots by using touch screen voting machines and 39 percent voted by paper ballot. Hanover, Lemont, Barrington, Orland and Schaumburg townships had the highest percentage of voters using touch screens, ranging from 76 to 72 percent respectively. Only Calumet and Riverside townships had a majority of voters who used paper ballots.


MORE VOTERS AGREE: “DON’T WORRY, VOTE EARLY”

A greater number and a higher percentage of voters cast ballots before Election Day for the Presidential Primary than any time since its March 2006 debut. The February 5 primary was the fifth election to offer Early Voting in Illinois, and more than 51,000 people voted at the 44 designated Early Voting sites in the Cook County suburbs. That’s more than three times as many voters as March 2006 when 15,600 voted early.

Altogether, 60,000-plus people cast ballots before the February 5 primary, including 9,400 absentee and grace period voters.



EARLY VOTING TURNOUT BY TOWNSHIP

Orland Township had the greatest number of early voters with nearly 13 percent of all people who voted in the primary election casting ballots before Election Day. In six other townships – Schaumburg, Northfield, New Trier, Evanston, Lemont and Rich – more than 10 percent of voters cast ballots between January 14 and February 4, 2008.



EARLY VOTING AND TOUCH SCREENS: SURVEY SHOWS WIDE SUPPORT

All Early Voting took place on touch screens from January 14-31, 2008.

On several randomly chosen days, we asked voters at nine of the 44 Early Voting locations in suburban Cook County to fill out surveys about their voting experience. The results were almost unanimously positive.

Over 800 voters responded. On a subset of those days, we also asked voters how they heard about Early Voting to assess our outreach efforts.


- 99 percent of the early voters surveyed had a positive early voting experience.
- Voters gave a wide array of reasons for voting early, but most commonly cited convenience (27 percent), traveling (23 percent) and avoiding crowds (20 percent).
- Voters were most likely to hear about Early Voting from the media (52 percent). A substantial percentage heard about it through a mailing (17 percent), or directly at a government office (8 percent).
- These findings are consistent with Early Voting surveys administered to thousands of early voters in suburban Cook County during past elections, in which over 98% of voters said they had an excellent or very good voting experience.

EARLY VOTING AND TOUCH SCREENS: SECURITY, FLEXIBILITY AND ACCESSIBILITY

Touch screen voting allowed every ballot style to be available to voters at every Early Voting location. That way, voters who lived in one area could vote in another. For example, voters cast ballots near where they worked or where they accompanied an elderly relative to an Early Voting location.

Touch screens allowed the ballot to be presented in Spanish and Chinese as well as English. The touch screens also allowed voters with visual impairments to use an audio ballot. Touch screens have other accessibility features such as adjustable fonts and screen contrast.

All touch screens used in Illinois are equipped with a Voter Verifiable Paper Audit Trail (VVPAT or paper trail) to allow voters to double check their choices before casting their ballot. This paper trail is also used to conduct Cook County's standard-setting canvasses and audits, in order to verify the accuracy of touch screen voting.
